# LEADERSHIP FOR PEACE, SUSTAINABLE DEVELOPMENT AND HUMAN RIGHTS

#### 10.00 - OPENING SESSION

Tatiana VALOVAYA, Director-General, United Nations Office at Geneva



Tatiana Valovaya is the 13th Director-General of the United Nations Office at Geneva (UN Geneva) and the first woman to occupy this position. Ms. Valovaya has more than 35 years of experience in public service, diplomacy and journalism. She began her career in 1983 in the editorial office of the Economic Gazette in Moscow, first as a correspondent, then as deputy editor of the Department of World Economy.

In 1989, Ms. Valovaya joined the Permanent Mission of the Union of Soviet Socialist Republics to the European Union (EU), where she served as Third

Secretary. She then became Second Secretary of the Permanent Mission of the Russian Federation to the EU, until 1994. During her diplomatic career, she was in charge of financial and economic cooperation issues.

From 1995 to 1997, Ms. Valovaya worked at the Presidential Administration of the Russian Federation, where she was responsible for relations with the statutory bodies of the Commonwealth of Independent States (CIS). She then served as Head of the Monetary and Financial Policy Directorate at the Ministry for the CIS. From 1999 to 2012, Ms. Valovaya worked in the Government administration of the Russian Federation, as Deputy Director and then Director of the Department of International Cooperation.

Ms. Valovaya joined the Eurasian Economic Commission in 2012, as a Member of the Board (Minister) responsible for integration and macro-economic issues. In particular, she was in charge of implementing integration policies within the Eurasian Economic Commission, coordinating the formation processes of the Supreme Eurasian Economic Council, and the negotiation of free trade agreements between the Eurasian Economic Community and third countries. In addition, she was in charge of relations with international organizations.

In 1980, Ms. Valovaya graduated from the Faculty of International Economic Relations of the Moscow Finance Institute. She holds the scientific degree of Candidate of Economic Sciences (1st doctoral level scientific degree and the degree of Doctor of Economic Sciences from the Financial Academy under the Government of the Russian Federation). Ms. Valovaya has written more than 170 scientific and journalistic publications on issues of international monetary and credit relations, European and Eurasian economic integration and multilateral cooperation in the CIS framework. In addition to her mother tongue, Russian, she speaks English and French.

Micheline CALMY-REY, former President and Foreign Minister of Switzerland, professor, Global Studies Institute, University of Geneva



Micheline Calmy-Rey is currently a visiting professor at the Global Studies Institute, at the University of Geneva. She is the former President and Former Foreign Minister of Switzerland.

She was a member of the Geneva Parliament from 1981 to 1997 for the Social Democratic Party. During her term of office, she was President of the Grand Council and Chair of its Finance Committee. In 1997, she became State Councilor of the Republic and Canton of Geneva, in charge of the Finance Department. She was President of the Council of State

from 2001 to 2002. She is a member of the Board of Directors of BCGE (Banque cantonale de Genève) and the SNB (Swiss National Bank).

On 4 December 2002, she was elected Federal Councillor, a position she held until the end of 2011. As head of the Federal Department of Foreign Affairs, she was committed to broadening Switzerland's relations with the European Union. She promoted a stronger international Swiss presence and pursued a policy of active neutrality, promoting peace, respect for human rights and the fight against poverty. Among the highlights of her policy were the launch of the Geneva Initiative, her decisive contribution to the establishment of the Human Rights Council, the independence of Kosovo, and the mediations between Armenia and Turkey.

In 2007 and 2011, Micheline Calmy-Rey was President of the Swiss Confederation. She chaired the Council of Europe in 2010 and the Ministerial Conference of La Francophonie in 2010 and 2011.

Ms. Calmy-Rey is Doctor honoris causa of the International University of Geneva (IUG). She is a member of the Board of the International Crisis Group, Geneva Call, the Center for International Relations and Sustainable Development and the Leadership Council of the UN Sustainable Development Solutions Network (SDSN) and chairs the Martin Ennals Awards Foundation.

After a commercial school-leaving certificate, she continued her studies at the Graduate Institute of International and Development Studies in Geneva and obtained a master's degree in political science.

**Vaira VIKE-FREIBERGA**, President of Latvia (1999-2007); Co-Chair of the Nizami Ganjavi International Center (NGIC)



Vaira Vike-Freiberga was President of Latvia from 1999 to 2007.

Dr. Vike-Freiberga emerged as a prominent spokesperson on politics and science whilst Professor of psychology and interdisciplinary scholar at the University of Montreal (1965-1998). She has held leading positions in national and international scientific and scholarly organisations, as well as in several Canadian governmental, institutional, academic and interdisciplinary committees, where

she acquired extensive administrative experience.

Dr. Vike-Freiberga returned to her native country in 1998 to head the Latvian Institute, an organization devoted to promoting Latvian awareness abroad. In June 1999, she was elected President of the Republic by the Latvian Parliament and re-elected in 2003. As President, she is known for her role in Latvia's NATO membership and accession to the European Union (2004). She was named Special Envoy to the Secretary-General on United Nations reform and was official candidate for UN Secretary General in 2006.

Since the end of her presidency in July 2007, Dr. Vike-Freiberga is a member of several international organizations, including inter alia, co-chair of the Nizami Ganjavi International Center (NGIC), the Council of Women World Leaders, the European Council on Foreign Relations and the World Leadership Alliance. From 2014 to 2019, she was President of the World Leadership Alliance - Club de Madrid.

Dr. Vike-Freiberga has been awarded many medals, prizes and honours, including the 2005 Hannah-Arendt Prize for political thought, the 2010 Konrad Adenauer Prize for her contribution to the political construction of a united Europe, and the 2013 Knight of Freedom award of the Casimir Pulaski Foundation.

She holds a B.A. and M.A. from the University of Toronto, and a Ph.D. in experimental psychology (1965) from McGill University in Montreal.

#### **Garry JACOBS**, President & CEO, World Academy of Art and Science



Mr. Jacobs is currently Chief Executive Officer of the World Academy of Art & Science (WAAS), USA.

Besides this position he is the Chairman of the Board and Chief Executive Officer of the World University Consortium (WUC), USA; Vice President and Director of Social Science Research at The Mother's Service Society, India; Distinguished Professor of Transdisciplinary Social Science at the Institute for Person-Centered Approach, Italy; Editor of Cadmus Journal focusing on economy, security and governance; founder of Mira International, a

management consultant to businesses in Europe, North America and Asia on strategic growth and profitabilityMember of Club of Rome International (Switzerland); and Chairman of the advisory council of Global Institute for Integral Management Studies, India.

He is an American Social Scientist and management consultant focusing on new paradigm concepts and strategies in the fields of business, economy, education, governance and international security. The integrating theme in Jacobs' research is the social and psychological process of growth and development as it expresses at the level of the individual, organization, nation and the global community.

In the 1970s, he started researching on the theory and practice of individual, organizational and social development. Long before criticism of the GDP became prevalent, he co-developed the Human Economic Welfare Index (HEWI) as an alternative, which incorporates socioeconomic indices. He was the co-founder of the International Commission on Peace & Food and co-authored a report to the UN on "Uncommon Opportunities: Agenda for Peace & Equitable Development". As a management consultant, he has worked with major corporations in the US, Europe and India.

#### <u>Moderator</u>: <u>David CHIKVAIDZE</u>, Chef de Cabinet of the Director-General, United Nations Office at Geneva



David Chikvaidze has worked for over thirty-six years in the foreign service, in government and in the international civil service.

A keen observer of superpower relationships, particularly international political, security and nuclear arms control issues in the context of Eurasian and current regional security dynamics and challenges, he provides political advice and support to his fifth Director-General of the United Nations Office at Geneva (UNOG) as Chef de Cabinet and, before, as acting Senior Political Adviser. As Director of the UN

Library and Head of the UNOG Cultural Diplomacy programme, Chikvaidze implemented a new strategic direction, created synergies with world libraries, raised the Library's profile and its effectiveness for clients and developed new forms of cultural, intellectual, educational and academic outreach. He was Senior Adviser to the UN High Commissioner for Human Rights, in charge of Communications and NGO relations and spokesman for the Commission on Human Rights and other Human Rights Bodies.

At UN Headquarters and on field missions in 1993-2003, D. Chikvaidze performed a variety of politically sensitive duties: negotiating humanitarian aid in Pyongyang with the DPRK government; assisting Sergio Vieira de Mello in negotiating with Yugoslav authorities humanitarian needs and access in FRY, including Kosovo; assisting James A. Baker III on his confidential missions to Algeria, Morocco and Mauritania on the Western Sahara issue; post-earthquake disaster assessment and coordination in Tajikistan and Afghanistan; three visits to the Chernobyl nuclear power plant and to contaminated areas in efforts to assist victims; organizing the UN50 commemorative events in New York and San Francisco; etc.


Prior to joining the United Nations, Chikvaidze served as scheduler for President Gorbachev and as protocol officer for President Yeltsin. A diplomat by training, he was special assistant to the Soviet Ambassador and chief of protocol of the USSR Embassy in Washington, D.C. (1985-1990).

D. Chikvaidze holds a Ph.D. in political science, is author of occasional articles on international relations and has taught geopolitics and served as thesis advisor. He is vice president of the Swiss Forum for International Affairs and of the Geneva Diplomatic Club; Fellow of the World Academy of Art and Science, founding member of the Georgian Association of Switzerland and of the Sergio Vieira de Mello Foundation.

Born in Tbilisi, Chikvaidze is a citizen of Georgia. He is married and has one son and three grandsons.

#### 10.30 - Human Security and Peace Building

Moderator: Jonathan Granoff, President, Global Security Institute



Mr. Granoff is the President of the Global Security Institute.

He is an attorney, author and international advocate emphasizing the legal and ethical dimensions of human development and security, with a specific focus on advancing the rule of law to address international security and the threats posed by nuclear weapons.

He serves on numerous governing and advisory boards including: Lawyers Committee on Nuclear Policy, Fortune Forum, Jane Goodall Institute, the NGO Committee on Disarmament, Peace and Security, Parliamentarians for

Nuclear Nonproliferation and Disarmament, and Middle Powers Initiative. He is a recipient of the Rutgers University School of Law's Arthur E. Armitage Distinguished Alumni Award and a 2014 nominee for the Nobel Peace Prize. He is the Senior Advisor and United Nations Representative of the Permanent Secretariat of the World Summits of Nobel Peace Laureates, Ambassador for Peace, Security and Nuclear Disarmament of the Parliament of the Worlds Religions, former Adjunct Professor of International Law at Widener University School of Law, and Chair of the Task Force on Nuclear Non-proliferation and Advisor to the Committee on National Security of the International Law Section of the American Bar Association.

Mr. Granoff is the award-winning screenwriter of *The Constitution: The Document that Created a Nation* and a prolific author. He has been a featured guest and expert commentator on numerous radio and television programs and has presented expert testimony in the Parliaments of Canada and the United Kingdom as well as the US Congress and the United Nations.

Mr. Granoff earned his BA (cum laude) from Vassar College and his Juris Doctorate from Rutgers University School of Law.

# <u>Yukio Takasu</u>, Special Adviser to the Secretary-General on Human Security



Mr. Yukio Takasu of Japan has been appointed Special Adviser to the Secretary-General on Human Security successively since 2010.

He leads the follow-up to the General Assembly resolution (A/RES/66/290) on human security. He works closely with Member States, in partnership with United Nations system of Organizations and other stakeholders to advance the human security approach in the Agenda 2030, the New York Declaration for Refugees and Migrants, the Sendai Framework for Disaster Risk Reduction, and the Sustaining Peace Agenda. Mr. Takasu leads the United Nations advocacy efforts on

mainstreaming human security, advance the implementation of the Framework for Cooperation on the System-wide application of human security approach, advise the Secretary-General on the management of the United Nations Trust Fund on Human Security and future expansion of its donor base, and provide operational guidance to the Human Security Unit.

He has a long and distinguished career related to the United Nations activities in the Government of Japan, the United Nations, and as an academic. He has held several senior diplomatic positions with the Ministry of Foreign Affairs of Japan, including Permanent Representative of Japan to the United Nations, and senior positions in the United Nations, including Assistant Secretary-General, Controller of the United Nations.

Mr. Takasu has held academic positions at Harvard University, the University of Tokyo and the Graduate University for Policy Studies in Japan. Mr. Takasu was educated at the University of Tokyo (Faculty of Law) and Oxford University (Merton College).

# **Christian Dussey**, Ambassador, Director, Geneva Center for Security Policy



Christian Dussey is the Director of the Geneva Centre for Security Policy (GCSP).

Prior to this assignment, he served as Swiss Ambassador and Head of the Crisis Management Centre of the Swiss Federal Department of Foreign Affairs (FDFA). The Centre coordinates the governmental crisis response system during major incidents affecting Swiss citizens abroad (disasters, political upheavals, terror attacks, hostage-taking). In 2012, he was selected to serve as a fellow at Harvard University (Weatherhead Center for International Affairs), where he spent the academic year 2012-2013. Among other postings as a Swiss career

diplomat, Christian Dussey headed the International Security Section of the FDFA, served as political counselor at the Embassy of Switzerland in Moscow (Russia) and as diplomatic adviser to the President of the Swiss Confederation.

Prior to joining the diplomatic corps of the FDFA, he served for five years at the Strategic Intelligence Service of the Federal Department of Defence. Christian Dussey is also a general staff officer in the Swiss armed forces.

He is regularly invited to give lectures on crisis management at various universities and business schools. He was educated at the Fletcher School of Law and Diplomacy, Tufts University (MA), at the University of Fribourg, Switzerland (MA), and at Georgetown University, Washington D.C. (exchange student).

**Elisabeth Tichy-Fisslberger**, President of the Human Rights Council, Permanent Representative of Austria to the United Nations Office and other International Organizations in Geneva



Ambassador Elisabeth Tichy-Fisslberger has been serving as Permanent Representative of Austria to the United Nations Office at Geneva since December 2017. She is the current President of the Human Rights Council.

Prior to her appointment to Geneva, from 2007 to 2017, Ms. Tichy-Fisslberger served as Director General for Legal and Consular Affairs at the Federal Ministry for Europe, Integration and Foreign Affairs. Ambassador Tichy-Fisslberger joined the Austrian diplomatic service in 1988 and has a long record of working in various areas of European affairs.

Before joining the Austrian diplomatic service, she has worked for the European Commission in Brussels. Foreign postings included Dublin, London and a long spell in Brussels. Ambassador Tichy-Fisslberger has been the first Austrian National Coordinator on Combatting Human Trafficking as well as President of the Austrian Task Force on Combatting Human Trafficking since 2009. Since 2002 she has been a lecturer at the University of Vienna and from 2006 onwards also at the Diplomatic Academy, Vienna.

Ambassador Tichy-Fisslberger holds degrees from the University of Vienna in Law and Languages (French, Spanish). She is also fluent in English and Italian.

'Funmi OLONISAKIN, Vice-President & Vice-Principal International Professor of Security, Leadership & Development, King's College London



Professor 'Funmi Olonisakin is Vice-President and Vice-Principal International and Professor of Security, Leadership and Development at King's.

She is a founding member of the African Leadership Centre, which aims to build the next generation of African scholars generating cutting edge knowledge for security and development in Africa; and was Director of the Conflict, Security and Development Group (CSDG) at King's (2003 to 2013).

Prior to this, she worked in the Office of the United Nations Special Representative of the Secretary-General on Children and Armed Conflict. In 2015, she was appointed by the United Nations Secretary-General, Ban Ki Moon, as one of seven members of the Advisory Group of Experts (AGE) on the Review of the United Nations Peacebuilding Architecture. She was also appointed in 2016 as a member of the Advisory Group of Experts for the United Nations Progress Study on 'Youth, peace and security'. She serves on the board of the Centre for Humanitarian Dialogue and Chairs the Africa Regional Advisory Committee of the Open Society Foundation. The University of Pretoria appointed 'Funmi as an Extra-Ordinary Professor in the Department of Political Sciences in 2016. In 2018, the Director-General of United Nations Educational, Scientific and Cultural Organization (UNESCO) invited her to join the Council of the United Nations University.

Her fields of research include: Future peace through the lens of future people, the emerging African paradigm, Leadership perspectives in security and development and Youth, peace and security in developing societies. 'Funmi has positioned her work to serve as a bridge between academia and the worlds of policy and practice. Her most recent research has focused on 'Reframing narratives of peace and state-building in Africa' and on 'Future peace, society and the state in Africa.'

### Martin Griffiths, Special Envoy of the UN Secretary-General for Yemen



Martin Griffiths of the United Kingdom has been appointed as Special Envoy for Yemen by United Nations Secretary-General António Guterres in 2018.

Mr. Griffiths brings extensive experience in conflict resolution, negotiation, mediation and humanitarian affairs. Since 2014, he has served as the first Executive Director of the European Institute of Peace. Between 2012 and 2014, he has served as an adviser to three Special Envoys of the Secretary-General for Syria, and Deputy Head of the United Nations Supervision Mission in the Syrian

Arab Republic (UNSMIS). From 1999 to 2010, Mr. Griffiths was the founding Director of the Centre for Humanitarian Dialogue in Geneva, where he specialized in developing political dialogue between Governments and insurgents in a range of countries across Asia, Africa and Europe. He also worked in the British diplomatic service and for various international humanitarian organizations, including the United Nations Children's Fund (UNICEF), Save the Children and Action Aid. In 1994, he served in Geneva as the Director of the Department of Humanitarian Affairs, which preceded the establishment of the Office for the Coordination of Humanitarian Affairs. From 1998 to 1999, he served as Deputy to the United Nations Emergency Relief Coordinator in New York. He has also served as United Nations Regional Humanitarian Coordinator for the Great Lakes and in the Balkans.

Mr. Griffiths holds a master's degree in Southeast Asian studies from the School of Oriental and African Studies at the University of London, and he is a qualified barrister.

# **Tibor Toth**, Executive Secretary Emeritus, Comprehensive Test Ban Treaty Organization



Ambassador Tibor Tóth is the Executive Secretary Emeritus of the Preparatory Commission for the Comprehensive Nuclear-Test-Ban Treaty Organization (CTBTO), where he held the position of the Executive Secretary from 2005 until 2013.

Ambassador Tóth has been actively involved in international disarmament and non-proliferation issues for over three decades. From 1990 to 1993 and from 2003 to 2005, he was the Ambassador and Permanent Representative of Hungary to the United Nations in Geneva. From 1997 to 2001 he served in the same capacity to the

United Nations in Vienna. In these capacities he represented Hungary at the Conference on Disarmament, the International Atomic Energy Agency and its Board of Governors, as well as the CTBTO. He was also Ambassador and Permanent Representative to the Preparatory Commission of the Organization for the Prohibition of Chemical Weapons in the Hague, and from 1994 to 1996 served as the Deputy State Secretary of Defense responsible for international affairs.

From 1992 to 2004, he chaired the Biological Weapons Convention negotiations on an implementation and verification regime. In 1992 he negotiated the Chemical Weapons Convention provisions on the Executive Council and in 1990 he initiated the joint organization of the Open Skies Conference by Canada and Hungary (later depositaries of the 1992 Treaty on Open Skies, which established a programme of unarmed aerial surveillance flights over all NATO and Warsaw Pact countries).

Ambassador Tóth holds a degree from the University of International Relations in Moscow.

#### 11.30 - ECONOMY AND EMPLOYMENT

<u>Moderator</u>: <u>Phoebe KOUNDOURI</u>, President, European Association of Environmental and Resource Economists



Ms. Koundouri is a Professor (Chair) of Sustainable Development (Economics and Econometrics) at the School of Economics, Athens University of Economics and Business (Greece) and the elected President of the European Association of Environmental and Natural Resource Economists (EAERE).

Prof. Phoebe Koundouri is also the Founder and Scientific Director of the Research laboratory on Socio-Economic and Environmental Sustainability (ReSEES) at the Athens University of Economics and Business and an affiliated Professor at the ATHENA Research

and Innovation Center (Greece) where she directs EIT Climate-KIC Hub Greece of the European Institute of Innovation and Technology. She is also the co-chair of the United Nations Sustainable Development Network Greece (UN SDSN Greece), chair of the Scientific Advisory Board of the International Centre for Research on the Environment and the Economy (ICRE8) and chair of the scientific advisory board of the European Forest Institute.

Professor Koundouri held academic positions at the University of Cambridge, University College London, the University of Reading and the London School of Economics. She acts as an advisor to numerous national and international foundations and organizations, as well as national governments. Currently, Ms. Koundouri is a member of the drafting PR ministerial Committee for 10-year development plan for Greece. She holds, inter alia, a global leadership role in the UN SDSN for European Green Deal (EGD) implementation and is leader (together with Prof. Jeffrey Sachs) of the Senior Working Group on Transformation Pathways for the implementation of EGD. She is also a Commissioner of the New Lancet Commission on COVID-19 of the Lancet and the Sustainable Development Institute at the University of Columbia.

Prof. Koundouri is listed in the 1% of most-cited women economists in the world. She holds a PhD and MPhil in Economics and Econometrics from the University of Cambridge (UK).

# Olga ALGAYEROVA, Executive Secretary, UN Economic Commission for Europe



United Nations Secretary-General António Guterres appointed Olga Algayerova of Slovakia as Executive Secretary of the United Nations Economic Commission for Europe (ECE) in 2017.

Ms. Algayerova brings to the position a combination of leadership and diplomatic skills, as well as deep knowledge of the region's challenges and opportunities and a strong focus on building and nurturing partnerships among key stakeholders with the United Nations. Ms. Algayerova has been Permanent Representative of Slovakia to the International Organizations in Vienna since 2012, she was previously

President of the Slovak Millennium Development Goals between 2010 and 2012, as well as State Secretary in the Ministry of Foreign Affairs from 2006 to 2010. Prior to her diplomatic career, Ms. Algayerova worked in the private sector as Corporate Export Manager at Zentiva International, from 2004 to 2006. Previously, she was Export Manager for Slovakofarma for seven years, in charge of the export operations.

Born in 1959, she holds a master's degree in contemporary diplomacy from Malta University, a Master of Business Administration degree from the Open University Business School in the United Kingdom, and an Engineer of Economy diploma from the Bratislava Business School at Slovakia's University of Economics.

#### Sangheon LEE, Director of the Employment Policy Department, ILO



Sangheon LEE is the Director of the Employment Policy Department of ILO which leads ILO's action for promoting full and productive employment by developing integrated employment, development and skills policies.

Before his current position, he was the Special Adviser to the Deputy Director-General for Policy on Economic and Social Issues (2014-18), providing advice on analytical work, policy development and advocacy across a range of economic, employment and social issues as well as coordinating ILO's work at multilateral fora such as G20, G7, and BRICS.

Mr. Lee has written extensively on economic, employment and labour issues, including articles in the *International Labour Review* and *Socio-Economic Review*, as well as editing volumes under the global research project of *Regulating for Decent Work* (Palgrave Macmillan) and other research projects. He is also one of the main authors of ILO flagship reports such as the *Global Wage Report* and the *World Employment and Social Outlook*. He co-authored *Working Time around the World* (2007 Routledge).

Mr Lee holds a PhD in Economics from Cambridge University.

#### Pavlina TCHERNEVA, Bard College, author of Case for a Job Guarantee



Pavlina R. Tcherneva is an associate professor of economics at Bard College. She specializes in Modern Monetary Theory and public policy.

She previously taught at Franklin and Marshall College and the University of Missouri–Kansas City. From 2000 to 2006, she served as Associate Director for economic analysis at the Center for Full Employment and Price Stability, where she remains a senior research associate. She was a visiting scholar at the University of Cambridge Centre for Economic and Public Policy, and since July 2007 she has been a research associate at the Levy Economics Institute.

Tcherneva's book, *The Case for a Job Guarantee* (Polity, 2020), is a timely guide to the benefits of one of the most transformative public policies being discussed today. She has collaborated with policymakers from the United States and abroad on designing and evaluating employment programs. She also worked with Bernie Sanders' 2016 presidential campaign after her research on inequality garnered national attention.

Her research focuses on monetary and fiscal policies under sovereign currency regimes and the macroeconomic effects of alternative stabilization programs. In 2012, Tcherneva received the Association for Social Economics' Helen Potter Prize for the best paper in the Review of Social Economy

Ms. Tcherneva is a two-time grantee from the Institute for New Economic Thinking for her work on rethinking fiscal policy, job creation, and public goods provisioning. She holds a BA in mathematics and economics from Gettysburg College and an MA and a Ph.D. in economics from the University of Missouri–Kansas City.

**Umej Singh Bhatia**, Permanent Representative of Singapore to the United Nations Office and other International Organizations in Geneva



Mr Umej Bhatia is Singapore's Permanent Representative to the United Nations Office in Geneva since August 2019. He is concurrently accredited as Singapore's Permanent Representative to the United Nations Office at Vienna, Permanent Representative to the Preparatory Commission for the Comprehensive Nuclear-Test-Ban Treaty Organization and Resident Representative to the International Atomic Energy Agency in Vienna.

Elise is currently working as Senior Advisor to 4SD for the facilitation and development of the Nature-Based Coalition, led by China and New Zealand ahead of the UN Climate Action Summit.

She has been working in the field of sustainable development and climate change for fifteen years. In her last position, she worked for Climate Action Network International as Special Projects Director and was responsible for leading three global initiatives: the Climate Vulnerable Forum Summit, the Step Up campaign, and the Shift-SEA project for

shifting financial flows towards clean energy access in South East Asia. She also worked as an Advisor to Ambassador Khan, Chief Negotiator of the COP23 Presidency who led the Talanoa Dialogue, as an inclusive multi-stakeholder dialogue designed to raise climate ambition and accelerate action, aiming for the public good.

Mr. Jarraud is a scientist and a meteorologist with degrees from the Ecole Polytechnique and the Ecole de la Météorologie Nationale. He is a fellow of the American Meteorological Society, a member of the Société Météorologique de France, the Royal Meteorological Society and the African Meteorological Society as well as an Honorary Member of the Chinese Meteorological Society and the Cuban Meteorological Society.

Most notable achievement under his leadership are among others: Nobel Prize awarded to the Intergovernmental Panel on Climate Change (IPCC); WMO received the Montreal Protocol Partners Award; WMO and the International Telecommunication Union (ITU) host the United Nations (UN) System Chief Executives' Board (CEB). On 28 June 2016, Mr. Jarraud was nominated Knight of the National Order of the Legion of Honor of France, for his achievements in meteorological science and his mobilization of the international community in the fight against climate change.

Doctor Ibrahima Socé Fall is the Assistant Director-General for Emergencies Response.

Dr Fall was previously the Regional Emergencies Director for WHO in the African Region and has worked as the WHO Representative in Mali before being appointed by the UN Secretary General as Ebola Crisis Manager and Head of UN mission for Ebola Emergency Response in Mali in November 2014. He returned to WHO in March 2015 as Director of the Health Security and Emergencies Cluster in the Regional Office after a successful mission in leading partners' support to interrupting Ebola virus disease transmission in Mali. He

largely contributed the reform of WHO's work in emergencies from design to implementation following his contribution to ending Ebola in West Africa.

Prior to this role, Dr Fall was Regional Advisor in the WHO Regional Office for Africa in charge of strategic planning for the malaria programme as well as chair of the Roll Back Malaria Partnership's strategic planning workstream at global level. She served as a senior fellow at the Bill and Melinda Gates Foundation early in its new agricultural development program, on the jury for the Hilton Foundation Humanitarian Prize, and as a Rockefeller Foundation fellow. She has been honored by twelve universities in four countries with honorary degrees and by the Republics of Italy and Ireland. She was named the 2003 World Food Prize Laureate for her transformational leadership at the World Food Programme, which she led for ten years, and for the positive impact she had on the lives of women. With her World Food Prize, she created the Catherine Bertini Trust Fund for Girls' Education. She has received multiple awards for her work to improve the lives of children, for her management of internal reform processes, and for her advocacy for women and girls. She was appointed to senior positions by three UN Secretaries-General and five US presidents.

She has been named a Champion of the 2021 United Nations Food Systems Summit. She is a patron of Gender in Agricultural Partnership (GAP), a senior non-resident advisor to the Center for Strategic & International Studies (CSIS), and a member of the Leadership Council of Compact 2025 of the International Food Policy Research Institute and of the ACIES End Hunger Sustainably Program advisory board.

Alberto Zucconi was a faculty member of the Western Behavioural Science Institute (WBSI) in La Jolla, CA., and is a fellow of the International Leadership Forum (ILF), an online global think-thank, a senior staff member of the Carl Rogers' Peace Institute that has organized with the United Nations University for Peace cross-cultural communication and conflict resolution meetings with heads of state and diplomats. He has been working internationally for 35 years as a trainer, lecturer and consultant for public and private organizations and is currently teaching Client Centred Therapy and the Person-Centred Approach, at the post graduate level at the University of Siena (Italy), faculty of medicine.

From 2005 to 2009, Irina Bokova was Ambassador of Bulgaria to France, Monaco and UNESCO, as well as Personal Representative of the President of the Republic of Bulgaria to the Organisation Internationale de la Francophonie.

Irina Bokova was on the Forbes List of the world's most influential women for 2016. She has received state distinctions from more than 40 countries across the world and is Doctor honoris causa of leading universities across the world, such as King's College and University of Edinburgh, UK, Paris-Sud Saclay, France, Boston University, US, Catholic University of Milan, Italy, and others. In 2020 she is also elected International Honorary Member of the American Academy of Arts and Sciences in the category of Scientific, Cultural and Non-profit Leadership.

Irina Bokova was graduated from Moscow State Institute of International Relations. She was a Fellow at the University of Maryland, Washington, and followed an executive program at the John F. Kennedy School of Government at Harvard University.

### **Ralph Wolff**, Founder and President, The Quality Assurance Commons



Ralph Wolff is the Founder and President of The Quality Assurance Commons, and an independent policy consultant focusing on accreditation and quality assurance processes in the US and internationally.

He previously served as the president of the WASC Senior College and University Commission from 1996 through August 2013, and as Associate Executive Director since 1981. He is a member of the University Quality Assurance International Board (UQAIB) in Dubai, United Arab Emirates, and on the National Advisory Boards of the National Institute for Learning Outcomes Assessment

(NILOA) and for the Lumina Foundation on the Degree Qualifications Profile. A practicing attorney, Ms. Zagladina has served on the senior legal teams of Ernst & Young, Ruperti Project Services International, and Volkswagen Financial Services of Russia.

Ms. Zagladin holds degrees in International Law and Linguistics and Interpreting, both from Moscow State University. Ms. Zagladina is a member of the Moscow Region Bar Association, which is attached to the Ministry of Justice of Russia.

# 10.00 – ACADEMIA: INTEGRATING RESEARCH INTO POLICY-MAKING AND IMPLEMENTATION

**Moderator:** Emil Constantinescu, President of Romania (1996-2000)



Emil Constantinescu is currently professor at the Bucharest University Doctoral School and was Romanian President from 1996 to 2000.

From 1966, he was assistant, lecturer, at the Faculty of Geology at the University of Bucharest. He is author of 12 specialty books. He published over 60 studies in the most important scientific magazines from Romania and abroad.

Within his civic activities, he engages in the effort to set up the democracy in Romania, to defend human fundamental rights and

freedom, and in building the civil society. Proposed by the University Solidarity and the Civic Alliance, as unique candidate of the RDC for the presidential elections in 1992. After this first political experience, the Democratic Convention elected him as its president. Their party won in 1996 the local and parliamentary elections and Emil Constantinescu was elected through direct vote President of Romania on a four-year term. During his presidential mandate (1996-2000) Romania has engaged in a large-scale process of reform in economy, justice and administration. He opened the crucial way for Romania towards NATO and EU.

Later, Emil Constantinescu resumed his academic career and made further steps to consolidate the nongovernmental organizations role. He launched the XXI European Generation Forum and founded the Romanian Academic Forum. In 2008 founded the New Democracies Forum. He is awarded several prizes, among others the Prize of Romanian Academy; Palmas Academicas; Golden and Honorific medals from Comenius University in Bratislava. He was president of the international commission for supervising the parliamentary elections (2001) and presidential elections (2007) in Senegal and of the parliamentary elections in Tunisia (2011).

He graduated in judicial studies from the Law Faculty of the University of Bucharest and is assigned as probationer judge at Pitesti Local Court. The political climate forced him to attend the courses of the Geology. He became a doctor in Geology from the University of Bucharest; Doctor ès Sciences from the Duke University, USA.

# Michael Møller, Chair, Diplomacy Forum, Geneva Science and Diplomacy Anticipator



Mr Møller is the Chairman of the Diplomacy Forum of the Geneva Science and Diplomacy Anticipator Initiative.

He has over 40 years of experience as an international civil servant in the United Nations. He began his career in 1979 with the United Nations High Commissioner for Refugees and worked for the United Nations in different capacities in New York, Mexico, Iran, Haiti, Cyprus and Geneva.

Mr Møller served as Director-General of the United Nations Office at Geneva as well as Secretary-General of the United Nations Conference on Disarmament and

Personal Representative of the United Nations Secretary-General to the Conference of Disarmament from September 2013 to July 2019. Prior to that, Mr Møller served as Executive Director of the Kofi Annan Foundation from 2008 to 2011.

In recognition of his efforts to deepen public understanding of the vital role of the United Nations and its partners in Geneva, Mr Møller received a series of prizes from the City of Geneva, the Union Suisse des Attachés de Presse and, most recently, the Fondation pour Genève.

He currently performs activities of research, education and consulting for public and private organizations, and has coordinated projects of national and international renown. As scientific researcher, educator, author and international speaker, his main areas of expertise and interest

Ms. Khan has been an international public servant for over 30 years. Previously she was the Director of Emergency Programmes for UNICEF, and she has also held other senior positions including Director of Public-Sector Alliances and Resource Mobilization; Associate Regional Director for

Eastern and Southern Africa; and the UNICEF.

Representative in Jamaica. Ms. Khan has extensive field experience including assignments in Kenya; Mozambique; Democratic Republic of Congo; and Colombia. She also has broad United Nations-wide expertise stemming from assignments with the Inter-Agency Standing Committee for Humanitarian Affairs (IASC) in Geneva; the Executive Office of the Secretary- General; and the United Nations Development Group. Previously he led UNDP's policy team on 'inclusive globalization' – including trade, development finance, and migration. From 2008-2009, he provided support to the Office of the UN Secretary-General on the financial and economic crisis, and

engagement with the G20. Before moving to New York, Paul was a policy adviser on international development for the UK Treasury, including the period building up to and through the UK's Chair of the G8 and European Union in 2005.

Paul received his BSc in Economics and his MSc in Quantitative Development Economics from the University of Warwick. In 2016 he was awarded an Honorary Doctorate in Law (LLD), also by the University of Warwick.

#### Peter McGrath, Executive Director, InterAcademy Partnership



Dr. Peter McGrath is the Executive Director of the InterAcademy Partnership.

His 10-year research career focused on the insect transmission of plant viruses and included postdoctoral positions at the Scottish Crop Research Institute as well as Purdue University and the University of Arizona in the USA. Returning to the UK in 1997, he established his own business as a freelance journalist focusing on agricultural, environmental and scientific issues.

He joined The World Academy of Sciences (TWAS) in Trieste, Italy, in 2003 as writer/editor in the Public Information Office. From 2006, Peter began overseeing the implementation of TWAS's core capacity-building programmes, including South-South fellowships and other exchange schemes, research grants and various prizes, as well as the activities of the Organization for Women in Science for the Developing World (OWSD). Bautista concurrently serves as the main representative of the United Methodist Church—General Board of Church and Society (GBCS), which is the international public policy and social justice agency of The United Methodist Church. Bautista served as president of the Committee of Religious NGOs at the United

Nations. Bautista chaired the Council of Organizations in New York of the United Nations Association of the USA and elected in 2018 to serve in its Executive Committee.

Bautista teaches, writes and lectures in a variety of fields, including international affairs; NGO and civil society dynamics; social and political ethics and social transformation. He has taught politics and civil society at Kyung Hee University in Seoul, Korea and dynamics of society and community organizing at Saint Andrews Theological Seminary in the Philippines. He is currently teaching on Christian social ethics at John Wesley College in Tuguegarao City. He was awarded the Doctor of Divinity, honoris causa, by Union Theological Seminary in the Philippines in 2016.

Among awards he has received is the 1996 Martin Luther King Humanitarian Award given by Drew University; one of eleven around the world awarded a plaque of thanks five in Seoul, South Korea in 2017 by the Korea Democracy Foundation. Bautista is also the recipient of an award of honour in 2017 from the International Religious Liberty Association. #### Gabriela Barron, Honorary President, Inter-Parliamentary Union



Gabriela Cuevas Barron is the Honorary President of the Inter-Parliamentary Union.

She has been a senator since 1 September 2012. She is the Chairperson of the Foreign Relations Committee, responsible for analysis of Mexico's foreign policy, approval of ambassadors and consuls general, approval of international treaties signed by the Executive and deployment of troops outside national territory.

Within the Inter-Parliamentary Union (IPU), Senator Cuevas Barron is the Head of the Delegation of the Mexican Congress to the IPU. From 2014 to 2016, she was a member of the Committee to Promote Respect for International Humanitarian Law, which she chaired during the period from 2014 to 2015.

Senator Gabriela Cuevas Barron's political career spans more than 20 years. Convinced of being a participant in Mexico's democratic consolidation and conscious of promoting citizen participation in the country's affairs, at age of 15 she joined the National Action Party, which was the main opposition force during Mexico's transition towards democracy. In the same vein, together with a group of young people, she founded the Fundación Educa México, A.C., which is committed to improving education in Mexico.

Senator Cuevas Barron has served as a federal representative in the LXI Legislature (2009-2012); head of the local authority (equivalent to a mayor) of Miguel Hidalgo, Mexico City (2006-2009); representative in the Federal District Legislative Assembly (2003-2006); federal representative in the LVIII Legislature (2001-2003); advisor to the Undersecretary on Normativity and Media, in the Ministry of the Interior (2001); and research assistant at the Instituto Tecnológico Autónomo de México (2000-2001).

She has also published several articles and chapters on issues relating to human rights advocacy and women's empowerment. Senator Cuevas Barron features regularly in several Mexican (radio, television, and print) and international (print) media outlets. She studied Political Science at the Instituto Tecnológico Autónomo de México (2001).

### <u>Jovan Kurbalija</u>, Founding Director, DiploFoundation and Head, Geneva Internet Platform



Jovan Kurbalija is the Founding Director of DiploFoundation and the Head of the Geneva Internet Platform.

A former diplomat, Prof. Kurbalija has a professional and academic background in international law, diplomacy, and information technology. He has been a pioneer in the field of cyber diplomacy since 1992 when he established the Unit for Information Technology and Diplomacy at the Mediterranean Academy of Diplomatic Studies in Malta.

Prof. Kurbalija was a member of the United Nations (UN) Working Group on Internet Governance (2004-2005), special advisor to the Chairman of the UN Internet Governance Forum (2006-2010) and a member of the High Level Multistakeholder Committee for NETmunidal (2013-2014).

Since 1997 Prof. Kurbalija's research and articles on cyber diplomacy have shaped research and policy discussion on the impact of the Internet on diplomacy and international relations. His book, *An Introduction to Internet Governance*, has been translated into 9 languages and is used as a textbook for academic courses worldwide. Prof. Kurbalija lectures on e-diplomacy and Internet governance in academic and training institutions in many countries, including Austria (Diplomatic Academy of Vienna), Belgium (College of Europe), Switzerland (University of St. Gallen), Malta (University of Malta) and the United States (University of Southern California).

He holds a BA, LLM and PhD in Law from the University of Belgrade and an MA in Diplomacy from the Mediterranean Academy of Diplomatic Studies, Malta.

### <u>Cecilia Cannon</u>, Academic Adviser to the United Nations for its 75th Anniversary



Dr. Cecilia Cannon is the Academic Adviser to the United Nations for its 75th anniversary. She also directs the Graduate Institute's Executive Master in International Negotiation and Policy-making, and lectures in the Master of International Development and International Affairs.

Her current research focuses on the design, reform and effectiveness of International Organisations. Her broader research looks at the role and influence of non-state actors in international policy processes; and migration policy.

She served as Head of Research for the Global Governance Centre until December 2017, and currently directs the Graduate Institute's Summer Programme on the United Nations and Global Challenges. # 12.00 – RESTORING PUBLIC TRUST AND THE ROLE OF MEDIA

<u>Moderator:</u> <u>Donato Kiniger-Passigli</u>, Vice President, World Academy of Art & Science



Donato Kiniger Passigli is Vice President of the World Academy of Art and Science (WAAS) and is the WAAS Representative to the UN in Geneva. He currently serves as Senior Advisor for Peace and Security at the United Nations Institute for Training and Research (UNITAR).

He is a journalist and a member of the Italian Press Federation. Donato is an expert in crisis resolution, development cooperation, public and labor affairs. Until recently, he coordinated the Fragile States and Disaster Response Group at the International Labour

Organization (ILO). Donato specialized in promoting crisis response programs and initiatives in the wake of major humanitarian crises, addressing governance and employment deficits.

In his over 30 years at the United Nations, he was also a spokesperson for the UN Humanitarian Affairs Office (OCHA) and head of the Media and Public Affairs branch of the Hague-Based Organization for the Prohibition of Chemical Weapons (OPCW). Donato also served as chief of staff for the UN mission in Western Sahara and was head of external relations at the International Criminal Tribunal for Former-Yugoslavia and Rwanda. Previously, he acted as head of office in Belgrade for the UN peacekeeping mission and, as an economic affairs officer, managed large UN development programmes.

Donato specialized in humanitarian action and governance, conflict analysis, risk management, disaster needs assessment, business continuity and partnership-building. He authors articles, delivers lectures and training on the above subjects.

Donato earned his Master's degree in Political Science from the University of Florence, Italy, in 1981, and diploma of a postgraduate program from the Fondazione Ricerche Internazionali, Florence, held in 1981 and 1982 for diplomatic corps and international civil servants under the auspices of the Italian Foreign Ministry.

#### **Noel Curran**, Director General, European Broadcasting Union



Noel Curran is the Director General of the European Broadcasting Union.

He is a former Director General, Managing Director of Television and Editor of Current Affairs of RTÉ, Ireland's national television and radio broadcaster. As Director General, he radically restructured RTÉ following the financial crisis that began at the end of 2008 and successfully positioned RTÉ as a robust digital media organization. He was Managing Director of RTÉ Television before becoming Director General of RTÉ in 2010. Responsible for four television services, nine

radio services, and Ireland's biggest digital media products, Noel led RTÉ at a challenging time of editorial and financial crisis, bringing the organisation back to financial surplus and championing the return of award-winning investigative journalism. Overseeing RTÉ's substantial commercial trading arms, he positioned RTÉ for digital transformation despite severe financial constraints.

As an editor and producer, Noel's programming won numerous awards for journalism and he was Executive Producer on a range of live television events, including the Eurovision Song Contest in 1997, general election coverage, live entertainment series and factual programming. He is Adjunct Professor of Journalism at Dublin City University. A strong and long-time advocate of public service media, Curran is also an award-winning investigative journalist and producer.

Noel attended Trinity College, Dublin, and graduated from Dublin City University in both European Studies and Communications, specialising in national and international broadcasting policy.

#### Catherine FIANKAN-BOKONGA, Vice-President, Geneva Press Club



Catherine Fiankan-Bokonga is a senior UN correspondent (France 24, Radio Vatican & various African media) at the Palais des Nations in Geneva for 22 years.

Since September 2016 Catherine Fiankan-Bokonga is head of publication and chief editor of Swiss publication, Klvin Mag. She is elected Vice-President of the Association of Accredited Correspondents at UN (ACANU) and of the Swiss Press Club (Club Suisse de la Presse). Her internationally acclaimed work on sustainability has resulted in her appointment as a Climate Reality Mentor, a One Young World Ambassador, Honorary Advisor for the NGO Committee on Sustainable Development – New York, Global Teen Leader at We Are Family Foundation, members of World Oceans Day Global Youth Advisory Council and EarthEcho International Youth Leadership Council. **<u>Jeffrey Sachs</u>**, Director, Center for Sustainable Development, Columbia University; Special Advisor to the Nizami Ganjavi International Center (NGIC)



Jeffrey Sachs the Director of the Center for Sustainable Development at Columbia University, where he holds the rank of University Professor.

He is a world-renowned economics professor, bestselling author, innovative educator, and global leader in sustainable development. He is widely recognized for bold and effective strategies to address complex challenges including debt crises, hyperinflations, the transition from central planning to market economies, the control of AIDS, malaria, and other diseases, the escape from extreme poverty, and

the battle against human-induced climate change.

Sachs held the position of Director of the Earth Institute at Columbia University from 2002 to 2016. He is President of the UN Sustainable Development Solutions Network, a commissioner of the UN Broadband Commission for Development, and an SDG Advocate for UN Secretary General Antonio Guterres. From 2001-18, Sachs served as Special Advisor to UN Secretaries-General Kofi Annan (2001-7), Ban Ki-moon (2008-16), and António Guterres (2017-18).

Sachs has authored and edited numerous books, including three New York Times bestsellers: The End of Poverty (2005), Commonwealth: Economics for a Crowded Planet (2008), and The Price of Civilization (2011). Other books include To Move the World: JFK's Quest for Peace (2013), The Age of Sustainable Development (2015), Building the New American Economy: Smart, Fair & Sustainable (2017), A New Foreign Policy: Beyond American Exceptionalism (2018), and most recently, The Ages of Globalization: Geography, Technology, and Institutions (2020).

Sachs was the co-recipient of the 2015 Blue Planet Prize, the leading global prize for environmental leadership. He was twice named among *Time* magazine's 100 most influential world leaders and has received 32 honorary doctorate degrees. The *New York Times* called Sachs "probably the most important economist in the world," and *Time* magazine called Sachs "the world's best-known economist." A survey by *The Economist* ranked Sachs as among the three most influential living economists.

Prior to joining Columbia, Sachs spent over twenty years as a professor at Harvard University, most recently as the Galen L. Stone Professor of International Trade. A native of Detroit, Michigan, Sachs received his B.A., M.A., and Ph.D. degrees at Harvard.

**Fabrizio Hochschild-Drummond**, Special Adviser to the UN Secretary-General on the Commemoration of the United Nations 75th Anniversary



Fabrizio Hochschild Drummond of Chile is the Special Adviser on the Preparations for the Commemoration of the United Nations' 75th Anniversary at the Under-Secretary-General level.

Mr. Hochschild who has been serving as Assistant Secretary-General for Strategic Coordination in the Executive Office of the Secretary-General since 2017, supports the Secretary-General in coordinating the preparation for the commemoration of the 75th anniversary of the United Nations in 2020. In the

capacity of Special Adviser, Mr. Hochschild also supports the Secretary-General on issues related to frontier technologies to ensure the follow-up to the High-Level Panel on Digital Cooperation.

Mr. Hochschild has diverse UN senior leadership experiences at headquarters and the field, having served as Deputy Special Representative for the United Nations Multidimensional Integrated Stabilization Mission in the Central African Republic (MINUSCA) in 2016, UN Resident Coordinator, Humanitarian Coordinator and Resident Representative of the UN Development Programme (UNDP) in Colombia from 2013 to 2016, Director of the Field Personnel Division in the United Nations Department of Field Support, New York from 2010 to 2012; and as Chief of Field Operations and Technical Cooperation in the Office of the High Commissioner for Human Rights (OHCHR), Geneva from 2005 to 2009. He began his United Nations career in 1988 with the Office of the United Nations High Commissioner for Refugees (UNHCR) in Sudan and served in subsequent postings with UNHCR, the United Nations Relief and Works Agency for Palestinian Refugees (UNRWA), the Office for the Coordination of Humanitarian Affairs (OCHA) and in peacekeeping. He was posted in Sudan, Jerusalem, Bosnia and Herzegovina, Geneva, New York, Timor-Leste, Serbia and the United Republic of Tanzania.

Mr. Hochschild is a graduate of the University of Oxford, United Kingdom.

### **Jane FONDA**, Academy Award-winning actress, producer, activist and author



Jane Fonda is a renowned actress and activist. She is a member of the Women & Foreign Policy Advisory Committee of the Council on Foreign Relations; The board of Women's Media Center and she sits on the board of V-Day, an association dedicated to stop violence against women. She also established the Jane Fonda Center for Adolescent Reproductive Health which engages to broaden the understanding of adolescent development and reproductive health.

In 1995, Jane Fonda founded the Georgia Campaign for Adolescent Pregnancy Prevention (G-CAPP), aiming to reduce the high rates of adolescent pregnancy in Georgia.

Fonda has long been known for activism and advocacy on environmental issues, human rights, and the empowerment of women and girls.

In 1994, Fonda was named Goodwill Ambassador for the United Nations Population Fund. In 2000, Fonda travelled to Nigeria and produced a film, in collaboration with the International Women's Health Coalition, "Generation 2000: Changing Girls' Realities".

Fonda was born in New York City in 1937, the daughter of Henry Fonda and Frances Seymour Fonda. She attended the Emma Willard School in Troy, New York, and Vassar College. Fonda studied with renowned acting coach Lee Strasberg and became a member of the Actors Studio in New York. Along with starring roles in dozens of highly acclaimed productions, Fonda also took on responsibilities as a film and television producer.

Her subsequent work on stage and screen earned numerous nominations and awards, including Oscars (Best Actress in 1971 for "Klute" and in 1978 for "Coming Home") and an Emmy for her performance in The Dollmaker.

#### **Garry JACOBS**, President & CEO, World Academy of Art and Science



Mr. Jacobs is currently Chief Executive Officer of the World Academy of Art & Science (WAAS), USA.

Besides this position he is the Chairman of the Board and Chief Executive Officer of the World University Consortium (WUC), USA; Vice President and Director of Social Science Research at The Mother's Service Society, India; Distinguished Professor of Transdisciplinary Social Science at the Institute for Person-Centered Approach, Italy; Editor of Cadmus Journal focusing on economy, security and governance; founder of Mira International, a

management consultant to businesses in Europe, North America and Asia on strategic growth and profitabilityMember of Club of Rome International (Switzerland); and Chairman of the advisory council of Global Institute for Integral Management Studies, India.

He is an American Social Scientist and management consultant focusing on new paradigm concepts and strategies in the fields of business, economy, education, governance and international security. The integrating theme in Jacobs' research is the social and psychological process of growth and development as it expresses at the level of the individual, organization, nation and the global community.

In the 1970s, he started researching on the theory and practice of individual, organizational and social development. Long before criticism of the GDP became prevalent, he co-developed the Human Economic Welfare Index (HEWI) as an alternative, which incorporates socioeconomic indices. He was the co-founder of the International Commission on Peace & Food and co-authored a report to the UN on "Uncommon Opportunities: Agenda for Peace & Equitable Development". As a management consultant, he has worked with major corporations in the US, Europe and India.

#### Tatiana VALOVAYA, Director-General, United Nations Office at Geneva



Tatiana Valovaya is the 13th Director-General of the United Nations Office at Geneva (UN Geneva) and the first woman to occupy this position.

Ms. Valovaya has more than 35 years of experience in public service, diplomacy and journalism. She began her career in 1983 in the editorial office of the Economic Gazette in Moscow, first as a correspondent, then as deputy editor of the Department of World Economy.

In 1989, Ms. Valovaya joined the Permanent Mission of the Union of Soviet Socialist Republics to the European Union (EU), where she served as Third Secretary. She then became Second Secretary of the Permanent Mission of the Russian Federation to the EU, until 1994. During her diplomatic career, she was in charge of financial and economic cooperation issues.

From 1995 to 1997, Ms. Valovaya worked at the Presidential Administration of the Russian Federation, where she was responsible for relations with the statutory bodies of the Commonwealth of Independent States (CIS). She then served as Head of the Monetary and Financial Policy Directorate at the Ministry for the CIS.

From 1999 to 2012, Ms. Valovaya worked in the Government administration of the Russian Federation as Deputy Director and then Director of the Department of International Cooperation.

Ms. Valovaya joined the Eurasian Economic Commission in 2012 as a Member of the Board (Minister) responsible for integration and macro-economic issues. In particular, she was in charge of implementing integration policies within the Eurasian Economic Commission, coordinating the formation processes of the Supreme Eurasian Economic Council, and the negotiation of free trade agreements between the Eurasian Economic Community and third countries. In addition, she was in charge of relations with international organizations.

In 1980, Ms. Valovaya graduated from the Faculty of International Economic Relations of the Moscow Finance Institute. She holds the scientific degree of Candidate of Economic Sciences (1st doctoral level scientific degree and the degree of Doctor of Economic Sciences from the Financial Academy under the Government of the Russian Federation).

Ms. Valovaya has written more than 170 scientific and journalistic publications on issues of international monetary and credit relations, European and Eurasian economic integration and multilateral cooperation in the CIS framework.

In addition to her mother tongue, Russian, she speaks English and French.

David Chikvaidze has worked for over thirty-six years in the foreign service, in government and in the international civil service.

A keen observer of superpower relationships, particularly international political, security and nuclear arms control issues in the context of Eurasian and current regional security dynamics and challenges, he provides political advice and support to his fifth Director-General of the United Nations Office at Geneva (UNOG) as Chef de Cabinet and, before, as acting Senior Political Adviser. As Director

of the UN Library and Head of the UNOG Cultural Diplomacy programme, Chikvaidze implemented a new strategic direction, created synergies with world libraries, raised the Library's profile and its effectiveness for clients and developed new forms of cultural, intellectual, educational and academic outreach. He was Senior Adviser to the UN High Commissioner for Human Rights, in charge of Communications and NGO relations and spokesman for the Commission on Human Rights and other Human Rights Bodies.

At UN Headquarters and on field missions in 1993-2003, D. Chikvaidze performed a variety of politically sensitive duties: negotiating humanitarian aid in Pyongyang with the DPRK government; assisting Sergio Vieira de Mello in negotiating with Yugoslav authorities humanitarian needs and access in FRY, including Kosovo; assisting James A. Baker III on his confidential missions to Algeria, Morocco and Mauritania on the Western Sahara issue; post-earthquake disaster assessment and coordination in Tajikistan and Afghanistan; three visits to the Chernobyl nuclear power plant and to contaminated areas in efforts to assist victims; organizing the UN50 commemorative events in New York and San Francisco; etc.

Prior to joining the United Nations, Chikvaidze served as scheduler for President Gorbachev and as protocol officer for President Yeltsin. A diplomat by training, he was special assistant to the Soviet Ambassador and chief of protocol of the USSR Embassy in Washington, D.C. (1985-1990).

D. Chikvaidze holds a Ph.D. in political science, is author of occasional articles on international relations and has taught geopolitics and served as thesis advisor. He is vice president of the Swiss Forum for International Affairs and of the Geneva Diplomatic Club; Fellow of the World Academy of Art and Science, founding member of the Georgian Association of Switzerland and of the Sergio Vieira de Mello Foundation.

Born in Tbilisi, Chikvaidze is a citizen of Georgia. He is married and has one son and three grandsons.
