I am happy to report that the level of activities carried out in 2014, as described in recent newsletters, was really outstanding. So, first of all, I wish to warmly thank and congratulate all of you who have made this possible. Bravo!

Very special thanks also goes to the Members of our Executive Committee, to the continuous support of our Board of Trustees, and the valuable cooperation we have received from many important partners, working closely with us in united action.

On behalf of WAAS & WUC, I wish to thank all of them: Al-Farabi Kazakh National University, CERN, Club of Madrid, Club of Rome, Foundation for Culture of Peace, Green Cross International, Inter-University Centre, International Association of University Presidents, Library of Alexandria, Montenegrin Academy of Sciences and Arts, Mother's Service Society, Nizami Ganjavi International Center, Partnership for Change, Person-Centered Approach Institute and World Future Council.

Looking towards the future, later this year the United Nations Member States will decide on a Post-2015 Agenda for the whole world, to follow the Millennium Development Goals (MDGs) that unfortunately, were not reached by all countries. And in Paris, next November/December, we hope that all countries will agree on a major commitment to follow the Kyoto Protocol, crucial for the long term survival of all humanity. We are now in the process of preparing a

final draft report on a New Paradigm so that it can be circulated globally, before the end of 2015.

This year also promises to be one of unprecedented activities for WAAS and WUC. I have briefly mentioned under Upcoming Events 2015 what is being planned. Other events, either organized by WAAS/WUC, or by others, are still being planned. More information on them will be found on the WAAS website and in the upcoming issues of *Cadmus* and *Eruditio*.

Finally, I cordially invite all WAAS Fellows to actively participate in the expanded agenda of activities of WAAS & WUC, to join us in developing new programs, to help in the dissemination of our work and in forging links in our growing network of WAAS centers and partnerships.

# Honorary President's Report

Distinguished Fellows of the World Academy, my dear friends,

The year 2015 marks the 55<sup>th</sup> anniversary of the foundation of our World Academy. Our fast changing world constantly at the edge of

a catastrophe, but yet achieving remarkable successes, demands that our Academy (WAAS) undertakes new challenging tasks. It seems to me that the most prominent features of WAAS activities during the last several years were establishing several WAAS centers (from the first ones in Pondicherry and Podgorica to SDEWES and soon to be established center in Bucharest), initiating the foundation of the World University Consortium, cooperation with many famous civil society organizations, organization of numerous conferences — most recently with Al Farabi Kazakh National University in November 2014 — and unifying all these activities under one goal: human-centered civilization.

WAAS assures its impact through new breakthrough ideas leading to action. Since science is the main driver, outstanding scientists committed to global welfare have to be engaged in WAAS activities – our MoU with the

European Organization for Nuclear Research (CERN) is an excellent example, as is the connection of WAAS with a very successful series of scientific forums devoted to Sustainable Development, Energy, Water and Environmental Systems (SDEWES) initiated and led by WAAS Fellows and soon to be established collaboration with European Scientific Institute (ESI).

WAAS is already a member of Inter-Academy Panel (IAP) and Inter-Academy Medical Panel (IAMP), collaborates with World Academy of Sciences for the advancement of science in developing countries (TWAS), All European Academies (ALLEA) and United Nations Academic Impact (UNAI) and is starting to collaborate with League of European Research Universities (LERU), Pontificia Accademia and International Council for Science (ICSU).

Our 50<sup>th</sup> anniversary was marked by launching <u>Cadmus</u> Journal (now distributed to all Fellows and also to members of many other civil societies) quickly followed by an e-journal <u>Eruditio</u> and Academy's Newsletters. We hope that similar major breakthroughs will label our 55<sup>th</sup> anniversary, and the forthcoming conference in Baku organized together with the Nizami Ganjavi International Center following the Club de Madrid conference, April 27-30, provides such an opportunity.

# Chairman's Report

Dear Fellows,

The Academy has been engaged in a multitude of dynamic activities this year. To provide a detailed report on all of these would be like preparing a small manuscript for publication so I shall try to focus on high points.

One of the most important initiatives developed by the Academy is the creation of the World University Consortium. The Consortium has a Board of Directors and continues to make progress on such matters as WUC courses, WUC membership issues as well as the WUC website and promotional materials. Alongside these developments, a number of MOOCs have been produced and distributed on subjects of interest to the WUC and the World Academy in general. More are planned and the participation of the Fellows is greatly welcomed.

The Academy had a major meeting in Almaty, Kazakhstan last year. The meeting was regarded as an enormous success with promise of more cooperation in the future. Last year, the Montenegrin Academy of Sciences and Arts launched a well-attended international conference on Transition to a New Society. The proceedings were edited by Momir Djurovic and have been published, and are worth acquiring. Our April 2014 conference in Baku will be followed up this year by a much larger Baku conference on the new paradigm in human development. We hope Fellows will be able to participate in this as well. We also plan a major conference on the theme of Anticipation which will be held in Trento, Italy. Additionally, we are co-sponsoring the XII International Colloquium Visions of Sustainable Development: Theory and Actions in Gainesville, Florida, in May.

In addition, we will be joining the WUC in organizing more courses in the Inter-University Center, Dubrovnik. **Alberto Zucconi** and **Ivo Šlaus** are working with The Vatican about the prospect of doing some collaborative work with them.

The Nominations and Evaluations Committee has streamlined its functions and the Board is carefully considering the direction of our evolving partnership strategies. In this regard, our focus on cooperation has been on

the movement, intellectually and scientifically speaking, of the new paradigm thinking. The success of our journals has helped to facilitate this process. However, we realize that this shift is not only vitally important for a salvageable global future but is also a shift that is incredibly challenging.

I also want to draw attention to a policy position that the Board agreed to over a year ago concerning public policy statements. One aspect of the public policy statements issue is whether we should take up particular cases of scientific repression of individuals and target specific governments. This is a matter that generated lively discussion and useful memorandum were exchanged. I suspect that we shall have to revisit this matter again and it may be of value that these memos be distributed to the Board of Trustees for further deliberation.

Finally, although I am not charged with financial matters, I believe that the time is right for us to think about how to specifically approach a cluster of major donors for future funding. There is a great deal more to say but the most important issue is the issue of shaping the framework of global ideas for the future. In this, we have made considerable progress over a short period of time and we may have to give more attention as to how to package and publicize the importance of these ideas in terms of the shape of global public opinion.

# Executive Committee's Report

Three years ago WAAS Fellows adopted a new constitution and instituted an elected Board of Trustees for the first time in decades. Since then many steps have been taken to orient and position the Academy to play a greater and more active role in global affairs attuned to the needs of humanity in the 21st century.

- Five officers, a seven-member Executive Committee, an eighteen member Board, a full-time administrative office in Pondicherry, a Nominations Committee and a Membership Communications Committee are now meeting regularly and working actively to generate new momentum for the Academy.
- More than 100 new Fellows have been elected, and even more significant, the number of Fellows actively committed to promoting the work of the Academy far exceeds earlier times.
- In recognition of the need for global action, WAAS has created an active network which presently includes
   7 WAAS Centers and 12 other eminent partner organizations.
- The number, range and variety of WAAS activities are many times greater than at any time in the past.
- A comprehensive program of work addressing critical issues has been formulated under the heading New Paradigm encompassing and integrating political, economic, technological, scientific, social, cultural, psychological and ecological dimensions of global society.
- Reviving an original intention of our founders to establish an informal world university, the Academy has established the World University Consortium in partnership with other leading international organizations.

- Two journals and five newsletters are being published annually.
- A revamped website containing detailed reports on recent and upcoming events and hundreds of articles, books and working papers is being maintained up-todate.

It is evident that the eminent group of intellectuals who founded WAAS did not intend to create one more traditional academy. Nor were they seeking to honor themselves or their colleagues by creating an

élite membership group. The Academy was established out of deep concern for the social consequences and policy implications of knowledge, a firm belief that fresh thinking and new perspectives are needed that go beyond the conventional wisdom now guiding human affairs, and confirmed faith in the power of ideas to change the world. Thus, the mission of WAAS to provide *Leadership in Thought that Leads to Action*.

The past three years have been an important transition period for WAAS, but the real work of realizing the Academy's mission lies in the future. We need and invite the active participation of all Fellows to join in a collective effort to make WAAS a dynamic and creative contributor, a model for a new type of organization, a pioneer reaching out to collaborate with other like-minded organizations in pursuit of common goals and shared values.



# Framework for a New Paradigm of Human Development April 29-30, 2015, in BAKU, Azerbaijan

The accelerated pace of change in the global economic, political, technological, scientific, social and environmental spheres, growing complexity of the interactions and increasing integration of inter-dependencies between these spheres present unparalleled challenges to human security, welfare and well-being. Persistent poverty combined with rising levels of unemployment, inequality, social unrest, armed conflict, resource depletion and climate instability are symptomatic. These challenges have defied solution by piecemeal, sectoral strategies based on existing concepts and national level policy initiatives.

The current paradigm is destroying natural, human and social capitals and obstructing the evolution of essential institutions for global governance and human welfare. A change of course is essential. Faulting current approaches has so far proven insufficient to bring about a significant change in thinking and action. The potential upside of alternative futures has not been sufficiently documented or projected. The call for a fundamental paradigm change is now accepted by many leading thinkers and institutions, but the precise nature of the change required and the process by which it can be brought about are yet to be defined. A comprehensive strategy is needed to substantiate that practical and effective solutions are possible to successfully address global challenges, backed by quantified research and reliable measures of the desired outcomes.

Over the past two years, the World Academy has organized a series of conferences at the United Nations in Geneva, Library of Alexandria, World Academy of Sciences (Trieste), Montenegrin Academy of Sciences and Arts (Podgorica), University of California at Berkeley, Washington DC, Ottawa, Baku and Almaty on solutions to the current global crises. These meetings have involved a detailed exploration of the limitations of current theory and public policy and formulation of a broad approach to develop a viable alternative paradigm. In addition, WAAS and Club of Rome have been individually and collectively engaged in examining core elements of New Economic Theory and formulation of a trans-disciplinary science of human development.

The conference will discuss a draft report and formulate action plans for implementing ideas proposed in earlier conferences organised by WAAS, Club of Rome, Green Cross International, Nizami Ganjavi International Center, Partnership for Change, World Future Council, World University Consortium and other consortium partners.

The conference to be held on April 29-30, 2015, in BAKU, Azerbaijan will create an action plan for implementing ideas proposed during the Almaty conference organised by the Academy, the World University Consortium and the Al-Farabi Kazakh National University.

The Anticipation conference is organized by The UNESCO Chair in Anticipatory Systems, together with the World Academy of Art and Science, International Society for the Systems Sciences, the Advanced Design Network, and the Department of Sociology and Social Sciences of the University of Trento.

Anticipation is coming to the fore as an emerging field of study that is influencing a wide variety of disciplines. This international conference will explore the interaction among anticipation, uncertainty and complexity. Some questions that we intend to raise are these: When does anticipation occur in behavior and life? What types of anticipation can be distinguished? What structures and processes are necessary for anticipatory action? How can anticipation be modeled? A better and more complete understanding of anticipation and its effects will improve theories and models of individual and collective human behavior and its consequences. The ability to anticipate in complex environments may improve the resilience of societies facing threats from a global proliferation of agents and forces by articulating uncertainties through anticipatory processes.

The twentieth century was a century of oil, not only that oil enabled the most fascinating period of growth in human history, fuelling international trade and bringing division of labour to really global levels. Meanwhile oil, being abundant only in some regions has created dependence of trading nations on, has caused many conflicts, and the security of its trade paths has become one of the pillars of the current world order. The price of oil, one of the most important parameters of global economy, reasonably being kept higher allowing for scarcity pricing, based on vacillating agreement between cartel of producers and developed countries, sometimes is being used as a political tool. But oil is exhaustible and conventional type which is cheap to produce may have already reached peaking, creating even higher pressure to control its production and trade. Shale oil and gas may postpone the day of reckoning for a decade or two, but will not change the paradigm. There are many alternatives, but which one is the best? Any energy future based on scarce resources will mean keeping the same paradigm which is utterly unsustainable and keeping humanity on the edge of war. Decoupling development from the use of resources, using only those that are renewable and locally available, would enable a switch to a new sustainable paradigm. Nations would not depend on the scarcity of mineral resources but on the ingenuity of its scientists. With open access to knowledge new technologies would quickly spread and bring prosperity to the entire humanity. Although the goal is set, there are many ways transition may take. The crucial will be integration of energy, transport, water, food and other life supporting systems reaping efficiencies. This special session is dedicated to contributions that would help gather knowledge of interconnections of insecurity and scarcity of resources, and of ways how decoupling of development from resources may help increasing security, bringing sustainable development. The contributions on the politics of new paradigm, the economics of its implementation but also on technical layout are welcome.

ESI cooperates with universities and academic centres on 5 continents, organizing interdisciplinary conferences, forums and workshops. These academic events gather researchers from different disciplines, giving them an opportunity to present their papers, transfer knowledge and share best practices.

ESI has bases in Macedonia, Portugal and Argentina and is an official partner of UNESCO's World Science Day celebration and a United Nations Academic Impact's member.

WAAS is to establish collaboration with European Scientific Institute soon at the above international forum. **Ivo Šlaus**, Honorary President of WAAS is the keynote speaker.

The Institute is an active supporter of the open access concept, publishing one of the largest open access interdisciplinary journals in Europe – the European Scientific Journal (ESJ). The journal promotes an agile and high-quality review procedure due to the excellent editorial team, composed of researchers from over 150 universities worldwide. Journal content is freely available to the public, contributing to the international dissemination of knowledge. ESJ's website is visited by more than 2 million researchers annually.

Numerous conferences are scheduled in the forthcoming year. New York, Buenos Aires, Tbilisi, New Delhi, Portugal, Barcelona, Amman and Oxford are some of the venues where interdisciplinary, multi-disciplinary and trans-disciplinary scientific approaches will be promoted.













# Post-Graduate Certificate Course in

## **Future of Education**

Education is the most sophisticated technology evolved by human beings for conscious social evolution. Yet the slow incremental development of education in recent decades has not kept pace with the very rapid evolution of society. WUC and WAAS are projecting far-sighted concepts for a human-centered paradigm in education for the 21st century. The deficiencies of the present system have been well-documented and key characteristics of the new paradigm have been identified. This course will undertake an in-depth examination of essential changes in perspective, goals, values, content and pedagogy of higher education. - From value-neutral to value-rich knowledge

- From discipline-specific to trans-disciplinary studies
- From theoretical to life-centric knowledge
- From socially insulated to socially-integrated educational institutions

#### **New Trustees**



lan Johnson (United Kingdom) — Dr. Johnson has experience in the areas of sustainable development, energy and economic policy. He spent twenty-six years

at the World Bank, starting as an energy economist and financial analyst and working through increasing levels of responsibility. He was, for his last eight years, Vice President for Sustainable Development and, for five years, also Chairman of the Consultative Group on International Agricultural Research (CGIAR).

Prior to joining the World Bank, he was an economist with the British Government and spent five years in Bangladesh working with the United Nations and a non-government organization.

Since leaving the World Bank Ian Johnson has been an advisor to the government of Chile, a member of the Swedish Commission on Climate Change, senior advisor to Global Legislators Organisation for a Balanced Environment (GLOBE) and chair of its Ecosystems Services Panel, as well as consultant to a number of international organizations.

Dr. Johnson has acted as an advisor to the UK government, the UNFCCC and IFAD.

From 2010-2014, Ian Johnson served the Club of Rome as Secretary General. He is an economist who has studied economics at the universities of Wales, Sussex and Harvard and business studies at Harvard.



Alexander (Switzerland) Professor Alexander Likhotal is the President of Green Cross International (GCI). He holds doctorates in

Political Science from the Moscow State Institute for International Relations (1975) and History from USSR Academy of Sciences (1987).

In addition to an academic career, he served as a European security analyst for the Soviet Union leadership. In 1991, he was appointed Deputy Spokesman and Advisor to the President of the USSR, Mikhail Gorbachev. After Mr. Gorbachev's resignation, Professor Likhotal served as his advisor and spokesman at the Gorbachev Foundation.

Professor Likhotal is actively involved in furthering sustainable development principles as President of GCI. He has launched internationally acclaimed initiatives such as the Earth Dialogues Forum and Green Cross International's global campaign for the Right to Water. He is also a member of the Club of Rome (Executive Committee), a Councilor at the World Future Council, Board member of the World Culture Forum and serves as advisor to the Club of Madrid. He has held academic positions at Northeastern University (Boston), the Institute of European Studies of the Russian Academy of Sciences (Moscow) and Security Dialogue Journal (Oslo). He has authored numerous publications and articles on environment, global politics and education.

# Sustainable Development Goals

#### Note to the Fellows of the World Academy of Art & Science

This note is to convey to you a policy position taken by the Board of the World Academy on the **Need to Support the Sustainable Development Goals.** 

First it would be useful for you to know that the Board decided last year that the Academy would take public positions in two instances:

- 1. When there are insights based upon the Substantive Work of the Academy, as it is a fundamental purpose of the academy to translate for public policy officials and other leaders of thought and action, insights and recommendations based upon scientific inquiry and perceptions from the arts, most particularly those arising from the studies and deliberations of the Academy itself.
- When there are challenges to the conduct of science and public policy by important institutions, groupings and personalities.

Based upon this policy, the Board, at its meeting in Almaty, Kazakhstan on November 8, 2014 took the position of endorsing the UN Open Working Committee Report for the UN's 2015-2030 Sustainable Development Goals, and urged the Fellows of the Academy to encourage their national governments to support the proposed package of goals and targets.

This note provides you with background and a recommendation for your action.

#### **Background:**

The Millennium Development Goals to cover 2000-2015 were a major success and arguably the biggest risk in reputation that the UN has ever undertaken. Fortunately for humanity (and the UN's reputation), the goals led to actions that have been major successes, particularly in spreading primary education, reducing infant and maternal mortality and in raising a very large number of people out of the worst forms of poverty. The set of these goals was relatively easy to agree since they were merely a compilation of the major goals individually agreed at political summits and UN conferences held in the 1990s.

The goals took place during a period of high growth that helped the ambitious poverty goals (halving the number of the poorest) to be achieved. When the goals were adopted there were 3 billion poorest in the world, but by 2010 the number was 1.5 billion, and with the recent World Bank rebasing of national GDPs, that figure is now 800 million. In no period of history has such rapid and positive economic and social progress been made.

#### **Challenge Now:**

At the Rio + 20 conference in June 2012, 192 governments

agreed to a position ("The Future we Want") that a set of goals and targets be established, as a successor to the Millennium Development Goals, to cover 2016-2030. These new goals would be called Sustainable Development Goals (SDGs). Outlined by an outstanding high level Commission co-chaired by the

heads of government of the UK, Liberia and Indonesia, the outline has now been articulated and expanded into 17 proposed goals and numerous targets for each goal. This work was accomplished by an Open Working Group of 30 governments with very active cooperation and participation by numerous global, regional and national non-profit organizations. There seems to be consensus among UN officials that the report of the Open Working Group will be the basis of UN General Assembly high level discussions in the Fall of 2015 when it is proposed that Sustainable Development Goals be adopted.

The relevant documents are the reports of the Open Working Group and the Rio+20 conference.

#### In summary, the goals are:

Goal 1. End poverty in all its forms everywhere

**Goal 2.** End hunger, achieve food security and improved nutrition and promote sustainable agriculture

**Goal 3.** Ensure healthy lives and promote well-being for all at all ages

**Goal 4.** Ensure inclusive and equitable quality education and promote lifelong learning opportunities for all

**Goal 5.** Achieve gender equality and empower all women and girls

**Goal 6.** Ensure availability and sustainable management of water and sanitation for all

**Goal 7.** Ensure access to affordable, reliable, sustainable and modern energy for all

**Goal 8.** Promote sustained, inclusive and sustainable economic growth, full and productive employment and decent work for all

**Goal 9.** Build resilient infrastructure, promote inclusive and sustainable industrialization and foster innovation

Goal 10. Reduce inequality within and among countries

**Goal 11.** Make cities and human settlements inclusive, safe, resilient and sustainable

**Goal 12.** Ensure sustainable consumption and production patterns

**Goal 13.** Take urgent action to combat climate change and its impacts

\*Acknowledging that the United Nations Framework Convention on Climate Change is the primary international, intergovernmental forum for negotiating the global response to climate change.

**Goal 14.** Conserve and sustainably use the oceans, seas and marine resources for sustainable development

**Goal 15.** Protect, restore and promote sustainable use of terrestrial ecosystems, sustainably manage forests, combat desertification, and halt and reverse land degradation and halt biodiversity loss

**Goal 16.** Promote peaceful and inclusive societies for sustainable development, provide access to justice for all and build effective, accountable and inclusive institutions at all levels

**Goal 17.** Strengthen the means of implementation and revitalize the global partnership for sustainable development.

While some two million or more people gave input to the formulation of the Sustainable Development Goals, only recently has the Open Working Committee's work been completed with the above set of proposed goals (accompanied by numerous targets). Although almost all governments approved the Rio+20 report that spelled out many of the topics on which the currently proposed goals are based, there has been no process of head-of-state level approval of the specific goals as had been the case of the Millennium Development Goals. So it is time for interested parties around the world to weigh in on the new proposed goals to help their governments understand the importance of approving most or all of the goals. Without more backbone in the political process there is a risk that the UN General Assembly debates scheduled to begin September 2015 will pick a lowest common denominator approach and the major opportunity to put sustainability on track will have been lost.

#### Why should WAAS Care?

If one reads the Open Working Group proposals or even a listing of the 17 proposed goals above, it is clear that the goals cover almost all the concerns that motivate WAAS in its pursuit of a new global paradigm that addresses human progress (including full employment), equity and sustainability. If the goals were enacted as global goals/targets and were well pursued, the quality of life on earth would greatly improve...all in directions that WAAS has outlined in its paradigm work. What the goals lack is an overall framework and strategy, but in the political context of vastly different governments and priorities, it may be the only way that such a set of goals can now be approved.

In most basic terms: Passage of the goals would immensely further the aims now being pursued by WAAS and make subsequent recommendations likely to arise from WAAS' Paradigm work on frameworks, values and education much more easily realizable.

#### **Recommendation to Fellows:**

The Board of Trustees, meeting in Almaty, Kazakhstan on November 8, 2014, agreed to support the proposed Sustainable Development Goals and will seek opportunities to encourage adoption of these goals. It also recommends that Fellows support the goals by writing to their governments to convey your own views and the collective view of the Academy that constructive support of the proposed Sustainable Development Goals in the 2015 fall meeting of the UN General Assembly is strongly encouraged.
